- 214 supporters opened the December newsletter, 8 clicked on the Youtube video of James & Alida and 7 signed our Advocacy petition on the Affordable Care Act.
- Holiday Assistance was a huge success as 180 children were matched with local sponsors. For the first year ever, the Holiday Assistance program was facilitated by volunteers, including BOD Alida Woods. The volunteers came in twice a week (sometimes three times) for 3 weeks where they tracked the sponsor drop-off of gifts, managed the logistics, and contacted the families for pick up. It is a program with many moving parts and everyone did an amazing job!

Advocacy Report

- Meetings with Rep. Brian Turner and his legislative assistant to discuss early childhood advocacy issues related to child care subsidy.
- Greg attended convening for Community Centered Health Home grantees in Winston-Salem with other members of the local leadership team. The day and half event provided a chance to learn from the other communities receiving funds and plan our work in Buncombe. The CCHH initiative is led by MAHEC and a key collaboration for the Success Equation.
- Greg attended the statewide strategy planning session for the Raise the Age effort in Raleigh. Our organization has been a local leader for this effort for almost a decade. There is optimism that the bill will pass this year.
- Success Equation Leadership Team moved forward with a 2017 Policy Agenda draft with the goal of finalizing in January and presented to the board for final approval in February.
- Action alert sent out on protecting health care with link to our petition. 262 emails were registered as open and 47 readers signed our online petition. We also created a blog for Mountain Xpress in December on the issue that has had over 1,700 views.
- Story: The momentum on Raise the Age is building. Having been part of this effort for almost a decade, I'm inspired by the advocates (old and new) that are moving this forward for 2017.

FRCE Report

- 35 families were served through the distribution of 38 food boxes.
- 61 children were served.
- Of the 61 children, 21 attend Emma Elementary, 8 attend Eblen Intermediate, and 1 attend Johnston Elementary.
- 2 families received Emergency Financial Assistance (serving 5 children).
- Emergency Financial Assistance totaled \$200.00.
- SSS Dani drove to Swanannoa to pay a portion of a client's rent in order to prevent a disgruntled landlord from starting the eviction process.
- The FRCE received a food donation from North Asheville Baptist Church.
- The FRCE received its weekly produce donation from Trinity and monthly food donation from 1st Congregations.
- SSS Dani attended a luncheon hosted by MAHEC that celebrated the hard work and commitment of the mothers and organizations involved in the Madre to Madre project in Emma.
- SSS Dani has been providing Triple P services to a mother from Buncombe County.
- The Holiday Giving Program's distribution process took place at the FRCE and all gifts were successfully picked up by 12/16 due to dedication and the organization of strong volunteers (coordinated and supported by Jodi Ford).
- Kelly "Crossface" Anundson (coach/pro-MMA fighter) organized a 3 day donation based Brazilian Jiu Jitsu seminar that was open to the public. The seminar took place and was hosted by FighterWithin Mixed Martial Arts in Hendersonville. Green River Picklers donated jars of "Appalachian Okra" and "WNC Ramp Rarity" to be raffled off. Ally's Bar of Horseshoe, NC donated tasty, nutritious snacks to keep participants energized throughout the event. Through the seminar, Children First/Communities in Schools received holiday gifts for families, a box full of food for the pantry, and \$319.00.

Learning Centers Report

- Our leaders wrote up mid-year reviews for each child and shared them with our caregivers. This was to guide the caregivers in supporting their child over the Winter Break.
- We had wonderful Winter Holiday Festivals at each site. Santa and his elves came. The children enjoyed making gingerbread houses, playing holiday games like dreidel for Hanukkah, and many other fun activities.
- Each child got to take home a few fun presents from Santa and an educational tool to work with during the winter break, such as Flash Cards, writing workbook, math workbook, etc.

Homework Club also provided a safe space to openly discuss heavy topics such as racism, discrimination, and stereotypes that students face in both school and their community).
- Nominated one of her students for a \$100 shopping trip to Target and the student was selected. The SSS joined the student and her mother on the Saturday of the event and helped the student practice budgeting skills.
- SSS and her supervisor met with the principal of Eblen Intermediate and officially signed off on the School Support Plan and provided a quarterly update.
- Made phone calls to families in regards to holiday assistance pickup and assisted with the program when necessary at the FRCE.
- Found a last minute donor for one of her families and picked up and distributed the gifts.
- Works heavily with families through the FRCE (check FRCE Board Report).

Student Support Specialist at Estes Elementary School

- Helped organize gifts and food boxes for Warm Winter Wishes holiday giving program for 103 students.
- Met with the assistant principal to discuss status of School Support Plan and asses any needed changes.
- Facilitated a parent-teacher meeting to address the behavior issues of a student and implement a plan to help improve the students' classroom conduct.

Project POWER/AmeriCorps Report
