Project Power/AmeriCorps is a national service program that recruits members to strengthen communities, get things done, build leaders and expand horizons. The primary objective of this program is to provide increased academic and cultural enrichment services to vulnerable youth in the city and county through a)Tutoring

In FY 2023, Americorps member recruited 1,219 volunteers who performed a total 33,474 hours of service to the community.
